NOTICE OF COMPETITION

Art. 1 - ORGANISING BODY

Banca Profilo C.so Italia, 49 - 20122 Milan

Art. 2 - AIM

The Competition has the aim of identifying and promoting young artists who distinguish themselves in the expressiveness of present-day art and for excellent abilities in technique, research and experimentation.

The Award foresees the awarding of prizes for the overall amount of **15,000.00 euros**, the creation of a Catalogue and the setting up of Travelling Exhibition that will visit the cities of: Milan, Turin, Brescia, Ferrara, Reggio Emilia and Rome.

The artist awarded **1st place** will also have the opportunity of a **personal exhibition** to be set up in one of the branches of the Bank (or in another location still to be defined).

The Inauguration Vernissage for the **Profilo d'Arte 2008**, with the Prize Awarding Ceremony will be held on the **07th October 2008** at the - **Museo della Permanente Via Turati, 49 - 20121 Milan.**

Art. 3 - DEADLINE

The Competition forms (with all of the attachments) must **absolutely** arrive by:

Art. 4 - CANDIDATES

The Award is open to all Artists, of all nationalities, born between **1st January 1968 and 31st December 1988.**

Art. 5 - WORKS OF ART

Each Artist can submit **only one piece of work** for consideration, which must be new and has never been shown before.

Only **painted work** is allowed created in **full stylistic and technical freedom** (oils, acrylics, inks, vinyl, watercolours, graphite, pencils, etc.) on any kind of support (canvas, paper, wood, etc.)

The work must be within the following sizes: from a minimum of cm. 50 x 50 to a maximum of cm.150 x 150.

Art. 6 – MODALITY FOR PARTICIPATION

- 1) Participation is free.
- 2) Documentation to be presented:
 - **Notice of Competition** and **Attachments** correctly filled in and signed.
 - Photocopy of a currently valid **document of identification**.
 - **Curriculum vitae** containing formative studies and a description of the exhibitions that the Artist has participated in.
 - **Photographic print** of the art work in colour, A4 size, clear and of good quality, (on the back of the photograph should be written: name and surname of the artist, year the art work was completed, title, technique and size).
 - A **CD-rom** containing an image of the art work to be submitted in *.tif or *.jpg extension and of a high resolution.
 - A brief description of the art work.
 - A **release** permitting the use of the image of the art work in the Competition (Attachment 1).
 - Authorization to **hold data** (Attachment 2).
- 3) The material submitted for selection will **NOT** be returned.
- 4) Banca Profilo reserves the right to use the images of the art works selected for the *Profilo d'Arte* Award 2008 for promotional reasons and to publicise the event.
- 5) **The Art Works will not be insured:** The Artist must arrange for any insurance at his/her own responsibility and expense, as well as the cost of the expedition and delivery.

N.B: If any of the Conditions for participating in the Competition are disregarded, even partially, the Artist will be excluded from the Competition.

Art. 7 - PRIZES

The Vernissage and Award Ceremony for the “**Profilo d'Arte 2008**” will be held in Milan on the **07th October 2008** at the **Museo della Permanente** - Via Turati, 49 – where the following prizes will be awarded:

1° Place – euro 7.000,00 and Personal Exhibition

2° Place – euro 4.000,00

3° Place – euro 2.500,00

N.B. The prizes are to be considered as gross of taxation.

Art.7.bis – PERSONAL EXHIBITION

The Artist awarded **1° Place will have a Personal Exhibition dedicated to him/her**, set up in one of the branches of the Bank (or in another location still to be defined), to be set up in a period of no less than three months after the conclusion of the Travelling Exhibition.

Art. 8 – JURY

The Jury that will select, from all of the participants, the art works to form the Exhibition “*Profilo d'Arte 2008*” will be composed as follows: Massimo Zanello (Councillor for Culture, Identity and Autonomy of the Lombardy Region), Rachele Ferrario (Art Critic), Marco Meneguzzo (Art Critic), Chiara Gatti (Art Critic), Velasco Vitali (Artist), Gianpiero Cantoni (Collector), Sandro Capotosti (Pr. Banca Profilo), Guido Podestà (Pr. Museo Permanente), Milena Gamba (Curator *Profilo d'Arte* Award).

Art. 8.bis – SELECTION AND TRAVELLING EXHIBITION

The Jury will have the task of selecting, based on the material received, the art works that will participate in the Exhibition of Contemporary Art - *Profilo d'Arte* 2008; the decision of the Jury is unappealable.

The Artists, thus selected, will be swiftly contacted by the Competition Organizers to arrange the times and method of delivery of the art works.

After the Award Ceremony the art works will remain on Exhibition at the **Museo della Permanente from 08 to 12 October** (Tuesday/Friday 10-13/14.30-18.30; Saturday/Sunday 10-18.30 – free admission) after that the Exhibition of Contemporary Art - *Profilo d'Arte* 2008 will assume a travelling nature for the calendar as follows:

Art. 9 - CATALOGUE

The art works composing the Exhibition - *Profilo d'Arte* 2008 – will be published, together with the biography of the Artist, in a Catalogue edited by Federico Motta Editor which will be presented on the occasion of the Inaugural Evening in Milan.

Each artist will have the right to receive a free copy of the Catalogue.

Art. 10 - CEDING AND USE OF THE WINNING ART WORKS

The Artists of the winning art works will cede to the Banca Profilo, freely and without any particular formality (ex art. 783 c.c.), the ownership of the art works in the Competition; as well as the exclusive rights for direct or indirect reproduction, temporary or permanent, in all or in part, of the art work in whatever form and for the duration as stated by the law.

Art. 11 - COLLECTION OF THE ART WORK OF THOSE NOT WINNING

The Artists of the art works that did not win will have to, at their own responsibility and expense, arrange for the collection of the said art work either in person or through a person presenting signed consent, within 30 working days from the end of the Travelling Exhibition, after which time the Banca Profilo will no not accept any responsibility for said works.

Art. 13 – RESPONSABILITY

The Organisers of *Profilo d'Arte* do not in any way accept any responsibility for any eventual damage the art works may receive during the period of the Event, in storage, on Exhibition, pending or in transport, caused by mishandling, fire, theft, or any other causes.

The Artists concede to Banca Profilo the reproduction rights of the art works and texts released “*Profilo d’Arte 2008*” for the creation of a Catalogue, filing and the publication of the art works in the Competition.

The participants in the Competition declare and guarantee that the art work presented is exclusively theirs both with regards to Author’s rights as well as financial rights for any gains and therefore there is no private right to be held by third parties on said art work.

Banca Profilo S.p.A. is therefore exonerated from any responsibility for any possible future protest or objection with regards to the originality or authorship of the art work and any eventual imitations or copies by third parties of the said art work.

In accordance with Art.13 of the Legal Decree dated 30 June 2003 n. 196 “Code with regards to the protection of personal data” the participants are informed that the data requested to participate in this Competition, including the data on the participation form, will be used exclusively for the aims foreseen by the Competition itself and will be the object of treatment carried out with or without the help of information technology systems, in full respect of the law cited above. AUTHORIZATION FOR HOLDING DATA

INFORMATION FOR HOLDING IDENTIFYING PERSONAL DATA

(Art. 13 of the Legal Decree n. 196 dated 30 June 2003 -
"Code with regards to the protection of personal data")

In accordance with Art.13 of the Legal Decree n. 196 dated 30 June 2003, you are informed as follows with regards to the personal data that is intended to be held.

1. Source and Aim

The treatment to which the personal data will be subjected to, as requested by or given to the Banca Profilo S.p.A. to participate in the Competition, including the data resulting from the participation form, and specified at the following point 2, is established before participation in the Competition.

All of the data supplied will be kept in accordance with the terms stated by the Event and eventually also later, if necessary to carry out completion of anything connected to or deriving from the Rules.

2. Types of Data

The categories of personal data are common data – defined by the law as “identifying” and “personal” relative to:

- Personal data;
- Past artistic and professional;
- Studies;
- Other data collected that allows the identification of the person directly interested and the art work.

3. Treatment and relative modalities

“Treatment of personal data” is intended as any operation carried out on the data from the time of the data being collected until the destruction of said data. The treatment can be carried out with or without the help of electronic means or in any case automatic means and includes, in respect of the limits and conditions as stated in Art. 11 of the Legal Decree 196/2003, also any communication and release, always with respect to that stated in Art. 19 and 25 of Legal Decree 196/2003.

4. Nature of conferring the data and consequences of any eventual refusal to respond

The conferring of personal data relative to the holding of, on its own facultative, is of an obligatory nature for those wishing to participate in the Competition and, in the realm of such, with respect for the Law/Regulations. The eventual, partial or total refusal to answer to or allow the holding of data will result in the impossibility of the Banca Profilo S.p.A., to carry out the above-mentioned aims.

5. Communication and release

The personal data relative to the treatment will be communicated and/or released with respect for the specified aims in previous point 1) as well as in the upholding of legal obligations.

6. Rights as seen in Art. 7 Legal Decree 196/2003

To the interested party of the treatment in question is recognised their right to exercise their rights as in Art. 7 of Legal Decree 196/2003, in particular the right to ask for the source of the data or for the updating, rectification or cancellation.
